

Why Give?

Christians give because we have received so much through Jesus. We are loved, forgiven, adopted into God's family and given everlasting life! 2 Corinthians 8:9 says "For you know the grace of our Lord Jesus Christ, that though he was rich, yet for your sakes he became poor, so that you through his poverty might become rich." In response we want to say 'thank you' to God and we also want to help others hear this best news in the world!



When God captures our hearts with what Jesus has done, then we give freely, excited by how our money can serve God. If God hasn't yet captured your heart with the message about Jesus, the first thing to do is to pray to him that he might show himself to you.

How much should I give?

You are free! In the Old Testament God's people gave 10% of their income to God, and a further 10% at special occasions. In the New Testament we aren't told a specific figure. Jesus rejoiced to see a poor widow give two small coins away (Luke 21:1-4) and Zaccheaus give masses of money away (Luke 19:1-10).

Some Principles for Giving

We are to give:

Generously

The Macedonian Christians are held up as an example to us: 2 Corinthians 8:2-5 "In the midst of a very severe trial, their overflowing joy and their extreme poverty welled up in rich generosity. For I testify that they gave as much as they were able, and even beyond their ability. Entirely on their own, they urgently pleaded with us for the privilege of sharing in this service to the Lord's people. And they exceeded our expectations: They gave themselves first of all to the Lord, and then by the will of God also to us."

According to what we have

Again in 2 Corinthians (8:12-13) Paul explains: "Our desire is not that others might be relieved while you are hard pressed, but that there might be equality. At the present time your plenty will supply what they need, so that in turn their plenty will supply what you need." In Jesus we have plenty and have the privilege of being able to give to help others.

Joyfully

God wants us to give cheerfully. We don't give to earn anything for ourselves but rather we give because God first gave us his Son Jesus Christ. 2 Corinthian 9:7 "Each of you should give what you have decided in Your heart to give, not reluctantly or under compulsion, for God loves a cheerful giver."
